Just Right Ventures LLC (“Just Right,” “we,” “our,” “us”) values your privacy. This Privacy Policy explains how we collect, use, share, and protect your personal information when you use the Just Right mobile application, website, and related services (the “Service”).

By using Just Right, you agree to the terms of this Privacy Policy. If you do not agree, please discontinue use of the Service.

1. Information We Collect

We collect the following types of information when you use Just Right:

a. Information You Provide

- Account details (name, email, phone number, date of birth, gender, general location)
- Profile content (photos, selfies, bio, interests, relationship preferences)
- Messages, voice notes, and interactions with other users
- Payment information (processed securely by third-party providers)

b. Camera & Media Access (Selfies and Photos)

With your explicit permission, Just Right may access your device’s **camera and photo library** to:

- Capture selfies for profile creation and identity verification
- Upload profile photos
- Enable features requiring camera use

Important:

- Camera access is only used when you actively choose to use it
- We do not access your camera in the background

- You can disable camera permissions at any time in your device settings

c. Location Information (Geolocation Services)

With your permission, we collect **approximate location data** to:

- Show compatible matches within your selected radius
- Enable Just Right Connect (proximity-based discovery)
- Improve matching accuracy

Privacy Protections:

- Your **exact location is never shared** with other users
- Location is **generalized and obfuscated**
- We do not display your real-time or precise location

User Control:

- Location access is optional
- You can disable it at any time
- Some features may be limited without it

d. Automatically Collected Information

- Device and app data (IP address, device type, operating system)
- Usage data (features used, interaction patterns, timestamps)

e. Third-Party Information

If you sign up using Apple, Google, or other services, we may receive basic profile information based on your permissions.

2. How We Use Your Information

We use your information to:

- Create and manage your account
- Provide compatibility-based matches
- Enable messaging, voice notes, and connections
- Support Just Right Connect features
- Process payments and subscriptions
- Personalize your experience
- Improve app functionality and performance
- Detect fraud, abuse, or violations
- Comply with legal obligations

3. Sharing Your Information

We do **not sell your personal data**.

We may share your information with:

- **Other users:** Based on your settings and connection type
- **Service providers:** Hosting, analytics, payments, customer support
- **Legal authorities:** When required by law or for safety
- **Business transfers:** In case of merger, acquisition, or sale

4. Cookies & Tracking Technologies

We use cookies and similar technologies to:

- Maintain secure sessions
- Improve app functionality
- Analyze usage patterns
- Personalize user experience

You may disable cookies in your browser settings, though some features may not function properly.

5. Your Choices and Controls

You have full control over your data:

- Profile visibility settings
- Camera access (on/off)
- Location access (on/off)
- Notification preferences
- Marketing communications (unsubscribe anytime)
- Account deletion

6. Data Retention

We retain your data as long as necessary to:

- Provide the Service
- Meet legal requirements
- Resolve disputes
- Enforce agreements

When you delete your account, your data is removed unless legally required to retain it.

7. Data Security

We use administrative, technical, and physical safeguards to protect your data. However, no system is completely secure.

8. Children's Privacy

Just Right is intended for users **18 years and older**. We do not knowingly collect information from minors.

9. International Users

Your data may be transferred and stored in the United States, where privacy laws may differ.

10. Your Privacy Rights

Depending on your location:

California (CCPA):

- Access your data
- Request deletion
- Understand how your data is used

EU/EEA (GDPR):

- Access, correct, or delete your data
- Restrict processing
- Withdraw consent
